# WHY ARE WE HAVING THIS MEETING?

#### A LITTLE BACKGROUND

- As chartered by the Town Board in 2018, an ad hoc Broadband Working Group starting looking at options to improve internet access in the Town Presque Isle.
- Since July 2021, the Workgroup (now a Committee) has made multiple presentations on progress to the Town Board, to other Town committees and local organizations, and to the general public.
- Our current goal is to work with an ISP partner to apply for a grant from the Wisconsin Public Service Commission (PSC) to help fund the recommended project
- The grant application is due by March 17, 2022

# WHY BETTER BROADBAND FOR PRESQUE ISLE?

- The Presque Isle Economic Development Committee (EDC) and Town Board believe that improved broadband internet access creates a positive economic impact for the entire Town
  - Allows Presque Isle to better compete for businesses and residential property buyers
  - Allows remote work options for full time residents, seasonal residents, and visitors
  - Gives visitors a reason to stay longer in the area and bring more monies into the local economy

- Provides access to tele-health services from both local and national providers
- Provides better options for remote learning for students of all ages

#### EXECUTIVE SUMMARY

- After consideration of multiple technologies, the Broadband Committee recommends that the Town of Presque Isle undertake a project to install fiber optic cable throughout Presque Isle Township to replace our dependence upon an obsolete copper-based infrastructure for internet access and other future telecommunications services.
- With a few exceptions (noted later in this presentation) fiber would be brought to the primary dwelling on all improved properties within the Town of Presque Isle; i.e., fiber to the premise, or FTTP.
- The Broadband Committee further recommends that the Town Board approve a financial commitment resolution for this project in support of grant applications to the Wisconsin Public Service Commission (PSC), with the Town acting as a partner with Charter Communications (Spectrum)

# EVALUATION RESULTS

Technology	Reasoning
Fixed Wireless	Eliminated from consideration due to technology and provider limitations
Starlink	Eliminated from consideration due to technology limitations as a town-wide solution; not PSC grant eligible
Mobile Services	Eliminated from consideration due to technology limitations as a town-wide solution; not PSC grant eligible
Fiber to the Premise	Recommended solution

# CANDIDATE FTTP PROVIDERS

- LUMEN (CenturyLink)
  - Current ISP for the Town
- Charter Communications (Spectrum)
  - Won RDOF auction in December 2020 for portions of the Town of Presque Isle

• Charter figures are based upon a PSC grant application due March 2022

#### LUMEN ELIMINATED

- Cost of LUMEN project to the Town is more than 3x Charter
- Risk associated with sale of LUMEN Wisconsin assets and staff to Apollo Management in August 2021; sale to finalize in Summer, 2022
  - New company will honor 2022 grant award, but priorities beyond that are unknown
- LUMEN would build over RDOF areas, which the PSC would view poorly
- LUMEN's plan based upon a phased approach requiring multiple grant awards

#### **RECOMMENDATION: CHARTER**

- This choice is the lowest cost to the Town and avoids the uncertainty of LUMEN's future under Apollo Management
- We can take advantage of Charter's RDOF commitment
- The requested grant amount is well within PSC guidelines
- A fiber-based infrastructure provides the widest opportunity for economic development in Presque Isle
- A fiber-based infrastructure will support other services beyond internet access; e.g., telephone service, television service, etc.
- A fiber-based infrastructure will improve the cost benefit for cell tower development in the Town

### COMMUNITY SUPPORT

- To date, we have received more than 90 letters of support from lake associations and individuals
- We have received more than \$14,600 in pledges to support the project and related costs
- We are currently reaching out to businesses, organizations, and individuals to solicit additional support

#### PROJECT DURATION

 Charter has confirmed that both RDOF and non-RDOF areas will be built the same way at the same time

 As non-RDOF areas are subject to PSC grant terms all work must be completed within 24 months of grant award

 Assuming a Summer, 2022 grant award and then contract negotiations, completion estimated at end of 2024

#### FINANCING

- The Broadband Committee recommends that the Town obtain a fixed rate loan from the Wisconsin Board of Commissioners of Public Lands (bcpl.wisonsin.gov)
  - "Since 1871, BCPL has invested in loans to municipalities and school districts for public purpose projects including economic development, local infrastructure, capital equipment and vehicles, building repairs and improvements, and refinancing existing liabilities to reduce future borrowing costs."
- All interest earned from BCPL loans is distributed annually to fund public school library materials throughout Wisconsin
- Annual payments are due March 15; loan executed this year would not require payment until 2023.
- The loan would be repaid through property taxes for all property owners within the Town of Presque Isle.

## WHAT HAPPENS IF WE DO NOT WIN A PSC GRANT?

- RDOF build out by Charter begins; timing TBD
- With Town Board approval, we will try again at the next grant cycle (6 to 12 months)

#### NEXT STEPS AND REMAINING ISSUES

- Formal resolution from the Town Board
- Resolution of LTD Broadband RDOF areas within Presque Isle
- Occupied islands may require alternative access options
  - Will need to be handled on case-by-case basis
- Potential administrative costs to oversee the project (TBD)
- Need to determine if Town budget can accommodate project cost without increase
- Memorandum of Understanding (MOU) with Charter signed upon grant award; contract negotiations to follow
- Finalize when Town's share of project cost is required by Charter
